On May 6, 2021, Helbiz, Inc. ("Helbiz"), which is the business combination target of GreenVision Acquisition Corp. ("GreenVision"), issued a press release announcing the launch of a fleet of safe and innovative e-scooters in Oklahoma City, OK after securing a one-year permit. This will include the Helbiz Apprenticeship Program, which provides career pathway opportunities in the high-demand mobility industry, and the Helbiz Access Program, which offers discounts on rides for low-income residents.
