On April 12, 2021, the Staff of the U.S. Securities and Exchange Commission (the "SEC") issued the "Staff Statement on Accounting and Reporting Considerations for Warrants Issued by Special Purpose Acquisition Companies ("SPACs")" (the "SEC Statement"), which clarified guidance for all SPAC-related companies regarding the accounting and reporting for their warrants. GreenVision Acquisition Corp. (the "Company") has re-evaluated the accounting treatment of its public and private placement warrants (collectively, "the warrants") as equity, and has determined, based on the SEC Statement, that its private placement warrants should be classified as liabilities measured at fair value, with non-cash fair value adjustments recorded in earnings at each reporting period. The Company is working diligently with an independent valuation expert to finalize the valuation of the private placement warrants, after which the Company intends to file an amendment to its Annual Report on Form 10-K for its fiscal year ended December 31, 2020 to restate its historical financial statements. Until the Company files such amended Form 10-K, it is unable to complete and file its Quarterly Report on Form 10-Q for the quarter ended March 31, 2021. As of the date hereof, the Company anticipates filing such Form 10-Q on or before the fifth calendar day following the prescribed due date for the Form 10-Q.
