On April 21, 2021, Helbiz, Inc. (“Helbiz”), which is the business combination target of GreenVision Acquisition Corp. (“GreenVision”), issued a press release announcing that Helbiz and YOLO Group, an Italian insurtech of digital insurance brokerage services, signed a Memorandum of Understanding to build an integrated mobility and insurance service. A copy of the press release is attached hereto as Exhibit 99.1.

Helbiz signs Memorandum of Understanding with YOLO to Build an Integrated Mobility and Insurance Service

Global micro-mobility leader Helbiz and the first Italian digital insurance brokerage group, YOLO, hope to accelerate the digital transformation for the insurance sector

Milan, April 21, 2021 - Helbiz, a global leader in micro-mobility that is the business combination target of GreenVision Acquisition Corp. (Nasdaq: GRNV), has signed a Memorandum of Understanding with Italy's first digital insurance brokerage group, **YOLO Group**. If completed, the partnership would enable Helbiz users to purchase accident insurance for shared vehicles for the duration of the rental on the Helbiz mobile app.

YOLO Group is a digital insurance broker that enables on-demand and pay-per-use underwriting of products from leading national and international insurance groups. Initially, Yolo intends to work with Helbiz to integrate protection solutions within Helbiz's mobile sharing platform. Ultimately, the two companies will work together to distribute insurance solutions beyond the rental of individual rides through Helbiz's digital properties. Offerings are expected to include on-demand insurance solutions dedicated to a variety of non-Helbiz related businesses, which will be part of a larger annual accident policy with liability and personal assistance coverage.

“Our innovative collaboration with YOLO Group, when completed, will allow us to be the first operator in the world to offer in-app insurance coverage for micro-mobility services and beyond,” said Ruggero Cipriani Foresio, Chief Marketing Officer of Helbiz. “YOLO Group shares our mission to enable innovative solutions that improve the quality of people’s lives worldwide. This service has the potential to support consumers using our products and those outside of the Helbiz spectrum. This partnership is part of Helbiz’s long-term vision to continue building customer-friendly services that aim to increase the level of rider trust and safety.”

“We are witnessing a gradual transition towards alternative and sustainable forms of transport,” said Roberta Pazzini, Head of Marketing & Communication of YOLO Group. “The ecosystem of mobility that is emerging is also creating interesting opportunities for the insurance sector, and this future partnership will enable new digital customers to take advantage of YOLO’s innovative services.”

About Helbiz

Helbiz is a global leader in micro-mobility services. Launched in 2016 and headquartered in New York City, the company operates e-scooters, e-bicycles and e-mopeds in over 30 cities around the world including Washington, D.C., Alexandria, Arlington, Atlanta, Jacksonville, Miami, Milan, Richmond and Rome. Helbiz utilizes a customized, proprietary fleet management platform, artificial intelligence and environmental mapping to optimize operations and business sustainability. Helbiz announced on February 8, 2021 it has entered into a merger agreement with GreenVision Acquisition Corp. (Nasdaq: GRNV) (“GreenVision”) a SPAC, which, upon closing, will result in Helbiz becoming the first micro-mobility company listed on Nasdaq.
